Thank you for your request dated 05 December 2023 under the Freedom of Information (Scotland) Act 2002 (FOISA).

For reference, you requested.

RFI 1: "What is the recorded levels of prisoner-on-prisoner violence in each of the past three financial years, 2021-2022, 2022-2023 and so far in 2023? Can this be broken down by prison and by year?"

RFI 2: "What is the recorded levels of prisoner-on-staff violence over the past three financial years, 2021-2022, 2022-2023 and so far in 2023? Can this be broken down by prison and by year?"

RFI 3: "What is the recorded levels of drugs (including legal highs) seized over the past three financial years, 2021-2022, 2022-2023 and so far in 2023? Can this be broken down by different types of drugs?"

RFI 4: "How many drug overdoses have been recorded in prisons in each of the past five financial years, 2019-2020, 2020-2021, 2021-2022, 2022-2023 and so far in 2023?"

RFI 5: "How many attempted suicides have been recorded in each of the past five financial years, 2019-2020, 2020-2021, 2021-2022, 2022-2023 and so far in 2023?"

RFI 6: "How many incidents of self-harm have been recorded in each of the past five financial years, 2019-2020, 2020-2021, 2021-2022, 2022-2023 and so far in 2023?"

RFI 4 Response: Under section 17 of FOI(S)A I can advise that SPS do not hold this information. There is no confirmed recording process for drug overdose within our incident categories.

RFI 5 Response: Under section 17 of FOI(S)A I can advise that SPS do not hold information in relation to attempted suicide. Whilst we record all significant incidents, we deal with people with a wide range of presenting behaviours which may be open to interpretation in relation to self-harm and attempted suicide. It is not always clear what the intention or motivation is and individuals may not disclose the reason therefore we are unable to accurately record or classify attempted suicides.

RFI 6 Response: Please see table below the number of individuals who are recorded as having self-harmed, broken down by years from April 2019 to 2023 (as at 21/12/23).
