Thank you for your request dated 19 August 2024 under the Freedom of Information (Scotland) Act 2002 (FOI(S)A).

For reference, you requested:

RFI 1: Please provide figures broken down by 2021/22, 22/23, 23/24 and 24/25 for a) acts of violence in the prison estate b) prisoner-on-prisoner acts of violence c) prisoner-on-staff acts of violence.

RFI 2: Broken down by every month since January 2024, how many prisoners have been placed on the 'Talk To Me' programme?

RFI 3: Broken down by every month since January 2024, how many prisoners have been held on Rule 95 conditions in cells out with Separation and Re-integration Units?

We have now completed our search for the information you requested.

RFI 3 Response: While we endeavour to provide information whenever possible, and we do hold the information that you have requested, in this instance the costs of locating, retrieving, and providing the information requested would exceed the upper cost limit set under section 12 of FOI(S)A. To clarify, to provide a response to your request for information in relation to how many prisoners have been held on Rule 95 conditions in cells out with Separation and Re-integration Units would require a manual check of all 12,318 instances of the use of Rule 95 in the period requested which would exceed the upper cost limit of £600 set by FOI(S)A.

This concludes our response to your request.

If you are unhappy with this response to your request, you may ask us to conduct an internal review, by writing to The Chief Executive, One Lochside, 1 Lochside Avenue, Edinburgh, EH12 9DJ. Your request should explain why you wish a review to be conducted and should be made within forty working days of receipt of this letter, and we will reply within twenty working days of receipt. If you are not satisfied with the result of the review, you then have the right to make a formal complaint to the Scottish Information Commissioner.
