BRIEF OVERVIEW OF SUPPORT NEEDS

Ms Bloggs requires to access multiple services on the day of her release including Housing, GP, Addictions services and Welfare Benefits. All services will be running on reduced capacity on Friday 24 December, and some will be closing early. We are concerned that limited access to services on Christmas Eve will leave Ms Bloggs vulnerable over the holiday weekend. Many services do not open fully again until 4 January 2022 and while emergency out of hours' services will be in place, they do not offer full access to the service required. Her ex-partner is also aware of her existing liberation date and has been abusive towards her in the past. An early release of 2 days would help Ms Bloggs transition back to the community safely and seamlessly with both practical and emotional support and enable appropriately timed access to the required services. This will ultimately reduce Ms Bloggs anxieties and risk of reoffending.
