Regarding the gender of those involved in assault incidents, while we endeavour to provide information whenever possible, and we do hold the information that you have requested, in this instance the costs of locating, retrieving, and providing the information requested would exceed the upper cost limit set under section 12 of FOI(S)A. To clarify, to provide a response to your request for information in relation to the gender of those involved in prisoner on prisoner assaults would require a manual check of all incidents in the period requested which would exceed the upper cost limit of £600 set under FOI(S)A.

This concludes our response to your request.

If you are unhappy with this response to your request, you may ask us to conduct an internal review, by writing to The Chief Executive, One Lochside, 1 Lochside Avenue, Edinburgh, EH12 9DJ. Your request should explain why you wish a review to be conducted and should be made within forty working days of receipt of this letter, and we will reply within twenty working days of receipt. If you are not satisfied with the result of the review, you then have the right to make a formal complaint to the Scottish Information Commissioner.
